golf, or maintaining the condition of the grounds on a public or private golf course and generally designed to carry persons including the driver. (See 625 ILCS 5/1-123.9).

2. Utility-Terrain Vehicles, also known as, "Recreational Off-Highway Vehicles" shall be defined as (not intended for 4 wheelers):

Any motorized off-highway device designed to travel primarily off-highway, 64 inches or less in width, having a manufacturer's dry weight of 2,000 pounds or less, traveling on 4 or more non-highway tires, designed with a non-straddle seat and a steering wheel for steering control, except equipment such as lawnmowers. (See 625 ILCS 5/1-168.8).

C. Requirements.

12. The operation of a Golf Cart or a Utility-Terrain Vehicle, as defined herein, shall not be operated in excess of the posted speed limit and may be operated only on streets where the posted speed limit is 35 miles per hour or less. This paragraph does not prohibit a said vehicle from crossing a road or street at an intersection where the road or street has a posted speed limit of more than 35 miles per hour. (See 625 ILCS 5/11-1426.1 (b)).

SECTION 3. SEVERABILITY


If any section, paragraph, clause or provision of this Ordinance is held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this Ordinance.

SECTION 4. REPEALER

All ordinances, resolutions, orders, or parts thereof, which conflict with the provisions of this Ordinance, to the extent of such conflict, are hereby repealed.

ORDINANCE NO. 2-10

AN ORDINANCE AMENDING REVISED CODE OF ORDINANCES
OF
CITY OF SESSER, ILLINOIS
RELATING TO
OPERATION OF QUALIFIED GOLF CARTS AND UTILITY-TERRAIN VEHICLES

WHEREAS, pursuant to the Revised Code of Ordinances of the City of Sesser Municipal Code, the City of Sesser, Illinois has established a law pertaining to operation of golf carts and utility terrain vehicles in the corporate limits of Sesser; and,

WHEREAS, after careful investigation, the City Council of the City of Sesser, Illinois has determined that changes to the original Ordinance No. 1-08 should be made.


NOW THEREFORE, BE IT HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF SESSER, FRANKLIN COUNTY, ILLINOIS THAT:

Section C item 9 pertaining to age be eliminated having been addressed previously in item 5 and item 14 be eliminated as the City recognizes the need from time to time to operate these vehicles on sidewalks and in park areas.

Section D item 1 the cost of a permit is hereby eliminated and will be furnished free of charge.




