

Contest Rules For

“Pay it Forward” HVAC Veteran’s Day Giveaway (the “Contest”)

1. **Sponsor (the “Company”):**
 - a. The Contest is sponsored by Professional Heating and Air, LLC, located in Sesser, Illinois 62884.
 - b. ProfessionalHeatingAir1@gmail.com

2. **Description of Contest/Giveaway:**
 - a. The giveaway is nomination based and open to all U.S. Veteran’s within the Southern Illinois area.
 - b. Nominated Veteran will be entered to possibly win a new HVAC system. Nominees may receive requests for additional information. Only needed equipment will be provided.
 - c. No purchase is necessary to enter to win. A purchase will not increase your chances of winning. Odds of winning depend upon the number of participants.
 - d. All federal, state, local, and municipal laws and regulations apply. Void where prohibited.

3. **Eligibility and Limitations:**
 - a. “Pay it Forward HVAC Veteran’s Day Giveaway Contest is open to legal residents within the Southern Illinois area, a Veteran, and who are at least eighteen (18) years old at the time of entry. Employees of Professional Heating and Air and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each employee are not eligible. The Contest is subject to federal, state, and local laws and regulations.
 - b. The winner must submit proof of eligibility and sign the Company’s release form to claim the prize.
 - c. All entries along with any voluntary photos become the property of the Company and will not be returned.

4. **Agreement to Official Rules:**
 - a. Participation in the Contest constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.
 - b. By participating in the Contest, participants agree to be bound by the decisions of Company personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified.
 - c. Unsportsmanlike, disruptive, annoying, harassing, or threatening behavior is prohibited. The Company will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Company’s decisions concerning such disputes shall be final.
 - d. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Company, the Company reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Company deems appropriate. All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion.

- e. Any attempt by an entrant or any other individual to deliberately circumvent, disrupt, damage or undermined the legitimate operation of this Contest is a violation of criminal and civil laws. Should such an attempt be made, the Company reserve the right to seek civil and/or criminal prosecution and/or damages from any such person to the fullest extent permitted by law.

5. Certain additional requirements are necessary to be a candidate:

- a. Prior to being determined a qualifying finalist the Sponsor will contact potential finalists for a HVAC inspection. Nominated entrants must allow Sponsor to enter the home for inspection before qualifying as a finalist. To become an official qualifying finalist, nominated entrants must meet all the Sponsor's restrictions and requirements contained in the official contest rules (below). Sponsor will determine if the qualifying requirements have been met before a finalist is eligible. All decisions made by the Sponsor are final and at their sole discretion.
 - i. Entrant must be a Veteran and nominated by another party. Eligibility to be determined by contest officials. Nominees may receive requests for additional information.
 - ii. Nominated entrant must be a homeowner at the time of entry and Winner has to own the home in which the heating and/or air system will be installed.
 - iii. Homeowner (Winner) must all Professional Heating and Air, LLC access within normal business hours on continuous days in accordance with Professional Heating and Air, LLC installation schedule.
 - iv. Prize awarded is specifically for the Pay it Forward HVAC Veteran's Day Giveaway and will not be applied towards any other heating and air conditioning work. The Company is not obligated to or bound by, and makes no representations, warranties or guaranty of any contract(s) or agreement(s) made by and between the Winner and the Sponsor.
 - v. The Grand Prize winner must be a homeowner and show proof of home ownership and homeowners insurance prior to taking possession of the prize. The location for the home heating and/or air makeover must within the Southern Illinois area. The winner's home must comply with all local and state code requirements.
 - vi. Homeowner must allow contractor access within normal business hours on continuous days in accordance with Professional Heating and Air, LLC schedule. Homeowners must get approval from any neighborhood association or other entity that maintains or enforces rules, laws, or covenants at the home's location.
 - vii. Prize must be redeemed within 3 months of the contest end date. Prize is non-transferable and is not redeemable for cash.

6. Contest Period:

- a. The Contest begins on October 1, 2018 at midnight central and ends on November 1, 2018 at 9:00am CST (the "Contest Period"). Entries that are submitted before or after the Contest Period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:
 - i. Online
 - ii. On-Site
 - iii. Mail-In

7. How to Enter:

All mail-in entries must be postmarked by 10/29/18 and received by 11/01/18

Limit one (1) entry form per person, per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person or household in excess of the stated limitation will be void.

8. Prize Determination / Announcement:

- a. A panel of judges will review all entries and choose a winner based on the circumstances of the person nominated, and that person’s ability to meet the criteria to be a finalist.
- b. The Sponsor will attempt to notify the potential via telephone or email on or prior to November 9, 2018. If the potential winner cannot be contacted, the Sponsor may select an alternate potential winner in his/her place.
- c. The Winner would need to be available and present on Saturday, November 10, 2018 at 1:00pm CST in the Sesser City Park for the Pay it Forward HVAC Veteran’s Giveaway live announcement.
