## Introduction

This report is intended to provide you with important information about your tap water and the efforts made by the water system to meet all U.S.E.P.A. and State drinking Water health standards. The City vigilantly safeguards its water supply and this report summarizes the quality of water that we provided last year, including details about where the water comes from, what it contains and how it compares to standards set by regulatory agencies. We are committed to providing you with this information about the water you are receiving. #### Water Source Assessment

Water is Purchased Surface water from the Rend lake Intercity water system. The source water assessment for our supply has been completed by the Illinois E.P.A. The Illinois E.P.A considers all surface water sources susceptible to potential pollution problems. Hence the reason for mandatory treatment of all public water supplies in Illinois. Mandatory treatment includes coagulation, sedimentation. Filtration and disinfection. Primary sources of pollution in Illinois lakes can include agricultural runoff, land disposal (septic systems) and shoreline erosion. # Health Issues

Some people may be more vulnerable to contaminants in drinking water then the general population. Immune-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/Aids or other immune systems disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. US E.P.A. / C.D.C. guide lines on appropriate means to lessen the risk of infection by cryptosporidium and other microbial contaminants are available from the USEPA'S Safe Drinking Water Hotline at 1-800-426-4791.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information about contaminants and potential health affects can be obtained by calling the USEPA's Safe Drinking Water Hotline at 1-800-426-4791.

In order to insure that tap water is safe to drink, USEPA prescribes regulations that limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

## Contaminant Source

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the surface of the land or through the ground, it can dissolve naturally occurring minerals and radio active material, and can pick-up substances resulting from the presence of animals or from human activity. Possible contaminants consist of:

- Microbial Contaminants such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic Contaminants such as salts and metals, which can be naturally occurring or result from urban storm water runoff, industrial or domestic waste water discharges, oil and gas production, mining or farming.
- <u>Pesticides & Herbicides</u> which may come from a variety of sources such as Agricultural, urban storm water runoff and residential uses.
- Organic Chemical Contaminant synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also, come from gas stations, urban storm water runoff and septic system's.
- <u>Radioactive Contaminants</u> which maybe naturally occurring or be the result of oil and gas production and mining activities.
- Lead: If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing you tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water you may wish to have your water tested. Maximum Contaminant Level (MCL); the highest level of a contaminant that is allowed in drinking water. MCL's are set as choice to Contaminant Level Goal as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no longer know or expectant health risks.

MCLG's allow for a margin of safety.

Mg/l or ppm:

milligrams per liter or parts per million- or one ounce in 7,350 gallons of water micrograms per liter or parts per billions- or one ounce in 7,350,000 gallons of water

ug/l or ppb: millirems per year (a measure of radiation absorbed by the body)

mrem: pCil/L:

Picocuries per liter- a measure of radioactivity

Regulatory compliance which some MCLs are based on running annual average of monthly samples

Maximum Residual Disinfectant Level (MRDL): the highest level of disinfectant allowed in drinking water

Maximum Residual Disinfectant Level (MRDLG): the level of disinfectant in drinking water below which there is no known or expectant health risks. MRDLG's allow margin of safety.

TT or Treatment Technique: A required process intended to reduce the level of a contaminant in drinking water.

Level 1 Assessment: A level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria

have been found in our water system.

Level 2 Assessment: A level 2 assessment is a very detailed study of the water system to identify potential problems and determine (if possible) why an E. Coli MCL violation has occurred

and /or why total coliform bacteria have been found in our water system on multiple occasions

The percentage of Total Organic Carbon (TOC) removal was measured each month and the system met all TOC removal requirement set, unless a TOC Violation is noted in the violation section.

# IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Monitoring Requirements Not Met for the SESSER Water Department.

Our water system was in violation of one (1) drinking water standard over the past year of 2023. Even though this was not an emergency, as our customers, you have a right to know what happened and what we did to correct the situations.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During November1 through November 30, 2023 we did not complete all monitor and testing for Stage 2 Disinfectants/Disinfection By-Products Rule (D/DBPS) for that Month due to IEPA failure to deliver resample bottles in time frame allowed and therefore cannot be sure of the quality of our drinking water during that time.

## What should I do?

There is nothing you need to do at this time.

The table below lists the contaminant(s) we did not properly test for during this testing period, when we were supposed to sample for Stage 2 Disinfectants/Disinfection By-Products. How many samples we are supposed to take, how many samples we took, when samples should have been taken, and the date on which follow-up samples were taken.

#### What happened? What is being done?

During the required testing period, IEPA laboratory encountered lab errors that required re-sampling, Re-sample bottles were not sent out by the IEPA during the time allotted to collect re-samples. All resamples did test in normal range so the water is safe to drink. A check and confirmation protocol will be done to insure that all future samples are collected in the required time frame.
